Report from Health Inspector Maria Schmitt:

Maria mentioned that the 1st round of inspections was completed, and they are currently half way through the Risk 3 and 4 inspections. The pool at Metropolitan was opened later due to an issue with a pump that needed to be replaced. There was only one instance of the water sample being high, but was fixed by the next week. Discussed the property maintenance complaints that came from Metropolitan, and she worked with Paula at Metropolitan so that they can enforce the property maintenance as it is private property. M. Cinque asked about Foremost Catering on the June report. Maria mentioned that there was an issue with their hot water, and needed to replace the hot water heater. M. Cinque asked about 70 Bruno Street. Maria mentioned that the Property Maintenance Official would follow up, and for mosquito problems, the County can be called to spray. Secretary mentioned speaking to DPW Assistant Superintendent regarding the property, and possibility of having DPW clean property and put a lien against the property. C/Surak mentioned that she would follow up on the issue at the Mayor and Council Meeting this week. Maria spoke about property on Albert Street, the same owner of the property on Monte Place. No one is living at either property, but when there are issues, she has the owner's phone number so that it can be cleaned up.
