Report from Health Inspector Maria Schmitt:

Since the report- the Quickmart is reopening with a different owner. They are also selling tobacco and hookah material, smoking is not allowed inside of the store. Those kinds of things would be regulated by the State.

Dog Bite- The dog was on the lawn and bit a child on the way to school in the morning. The owner was very cooperative and the dog has a rabies shot and was licensed. Maria is responsible for the rabies aspect and then Animal Control will investigate further, speaking to the parent and the owner. By the next meeting she will know what happened with Animal Control.

Attorney Morán asked if Animal Control will have a report.

Maria mentioned that she could get a copy of the report from Animal Control.

L. Martinez asked about the hospital on the report.

Maria mentioned that there was a hoarding situation at the mobile home park. She had to speak to the hospital, as she is not able to go into a one family dwelling.

M. Cinque asked about 7 Henry Street on the report and mentioned that someone has asked her about the conditions of the home and if the town is going to spray for mosquitoes again.

Maria mentioned that the house was sprayed by County Mosquito Control.
