The Regular Meeting of the Board of Health of the Borough of Moonachie is called to order by President M. Cinque in the Kathryn E. Flynn Civic Center on February 6, 2017 at 7:47pm.

President called for the Pledge of Allegiance to the Flag.

Secretary stated that notice of the meeting was announced in accordance with the Open Public Meeting Act.

Motion by L. Martinez, second by K. Surak to adopt the minutes of December 12, 2016 and January 9, 2017.

Report from Health Inspector Maria Schmitt:

Dog Bite- spoke about issues with owner and family members, the dog will be licensed this week. The dog needs a rabies booster. The dog was quarantined and released.

Food Applications - are okay need to set up inspections for the food trucks.

Garbage Complaints- Went by Vanguard twice as routine, no complaints.

M. Mezzina asked about La Isla.

Maria stated that everything is okay, did have to speak to her about getting the application into the office. If she misses a Food Handler class, or if there is an issue, Maria will be notified.

OLD BUSINESS:

Dog License Mailing

M. Cinque asked about responses from people that were found on the canvass.

Secretary stated that most of the responses are for renewals.

M. Cinque asked if they should send another mailing to the addresses from the canvass. Asked the amount of people it would be mailed to. Secretary stated it may be around 60. Board discussed what to include in the letter. Spoke about possibly telling park managers of the issue.

NEW BUSINESS:

Flu Clinic

Nurse called to set up order for Flu Clinic, mentioned that 9 people came last year. M. Cinque asked C/Surak to mention to the Council about the Flu Clinic. Board discussed the price for the contract with the County. C/Surak stated that he will look at the contract. Secretary spoke about the pricing for the vaccines, mentioned that the Flu Clinic is usually on the same day as the Senior Meeting and the Health Consultation. Maria stated that in other towns the clinics are going down, and that towns can offer vouchers to go to a specific store. M. Cinque mentioned about telling the Seniors early in the summer about the Flu Clinic date, it could be put into the July/Aug/Sept Messenger. M. Cinque asked

how many people the nurse sees at the Health Consultation. Secretary stated about 5 or 6 people and she only comes once a month, rather than twice a month in 2016.

M. Cinque asked C/Surak about the late fees, if the Council was alright with it.

C/Surak asked about Risk Levels on Inspection Report.

Maria stated that Risk 1 is prepackaged food. The Risk Level is the risk of getting sick from food preparation. Risk 2 would be Burger King, Risk 3 is most restaurants, Bazzarelli, Segovia; Risk 4 is sushi, or specialized food.

C/Surak asked about alternates.

K. Surak stated that the Board did not talk about it.

C/Surak stated that he can bring it up at the executive meeting this week, if anyone has any names.

L. Martinez asked Maria about the dog bite if the dog was licensed. Maria stated no and the owner has to get the dog a rabies booster and then a license.

C/Surak asked if Animal Control patrols the area.

Maria said they do, and they also get calls.

M. Cinque spoke about seeing deer in the area.

C/Surak asked if the Board has a recess.

M. Cinque stated that July and August there are no meetings unless it is needed.

M. Cinque thanked C/Surak for updating the Board of Health page on the Borough website.
