Mayor Vaccaro- spoke about the plans for the DPW Building which should be sent to the Borough in the next week for review. He asked C/Bauer to review the plans.

PUBLIC HEARING:

Sal DeAlessandro, 1 Frederick Street- spoke about height of the electric panel and hot water heater at the Firehouse. He asked if a grant was available for the work for electric panel and hot water heater.

Mayor Vaccaro -mentioned that there was no substantial damage at the Fire house and everything did not have to be up to code when they were repaired.

Mr. DeAlessandro –mentioned that the electrical panel was replaced at the time of the project.

Mayor Vaccaro- mentioned that he will review the plan for the fire house project.

Mr. DeAlessandro- asked if there were any changes with the traffic light at Moonachie Avenue and Moonachie Road.

Mayor Vaccaro-mentioned that he spoke to the County Executive and he will be meeting with County Executive to discuss the traffic light and the backflow preventer project that the County is working on.

Mr. DeAlessandro -spoke about the left turn traffic signal for the parking lot at the intersection of Moonachie Avenue and Redneck Avenue.

Mayor Vaccaro- mentioned that the Borough should not have to carry the whole cost for the project, the roads are county roads, it goes through Carlstadt, so the County and Carlstadt should be involved. Spoke about the County, who is looking into repaving Moonachie Road in the future, but it should be done after the Municipal Building is complete.

Mr. DeAlessandro -mentioned that the streetscape & the sidewalks have not been put back the way they should be after road openings and asked who is responsible for that. Mayor Vaccaro- mentioned that it is up to PSE&G, but he asked them to wait until the Municipal Building is done to do work on the sidewalks and crosswalks. He spoke about a home on the street being raised and open the side walk.

Mr. DeAlessandro mentioned about water main break near his home where there was striping.

Mayor Vaccaro -spoke about the emergency breaks, which was repaired. He mentioned that the DPW Superintendent has emailed Suez, that in the spring the roads will be put back in the same condition and he will find out about responsibility of striping.

Mr. DeAlessandro -spoke about the old fire Engine 801 which is at the DPW yard, He asked whether there is going to be a bay for it in the new DPW building or if it will be kept at the current DPW yard.

Mayor Vaccaro -mentioned that he does not know about the housing of the fire engine and the Fire Department had some ideas about where to house the engine. He mentioned that the Fire Department has not met with the Committee regarding housing of the fire engine and he will reach out to the Fire Department so that it can be discussed.

C/Bauer – mentioned that the Fire Department should set up a meeting with the Fire Committee.

Mr. DeAlessandro -spoke about last meeting of Rebuild By Design and there was lot of emphasis about maintenance of the project.

Mayor Vaccaro- spoke about the importance of a maintenance plan and if this plan gets approved then surrounding town will be benefited.

Mr. DeAlessandro- spoke about attending the County Freeholder meeting.

Mayor Vaccaro- mentioned that there is need for the maintenance plan so the maintenance is not reliant on an individual and the work will not be forgotten.

Mr. DeAlessandro- spoke about the information he left at the DPW when he left.

Mayor Vaccaro- mentioned that the Department of Public Works took Mr. DeAlessandro's knowledge and expanded by getting certain licenses and certification.

Motion by C/Surak and second by C/Bauer to close Public hearing.

All ayes. So ordered.

Motion by C/Surak and second by C/Bauer to go into closed session to discuss personnel at 8:35 P.M.

C/Bauer -expressed condolences to the Borough Clerk for her father, who passed away.

Mayor Vaccaro- mentioned that in the closed session, there was discussion about directing the Borough Attorney to send a memo to the PBA, about the letters to Department heads regarding evaluations and about an issue with a part-time dispatcher.

C/Surak- mentioned that the iPads are at the Borough Hall, and he needs to set them up so he needs information for the Borough's email accounts. He spoke about TANAAC meeting at which there were complaints about the new hangars being built and a new committee will be formed in regard to flooding issue at the airport.

Mayor Vaccaro- mentioned that the airport got all the permits from the NJDEP, and he had meeting with airport, the Mayors of Little Ferry and South Hackensack about the flooding in the surrounding towns. He asked C/Surak about the Committee.

C/Surak- answered that former Mayor Dressel and Renee from Airport are in this committee.

C/Surak- spoke about transferring the Network Solutions emails to Office 365. He mentioned that 28 emails will be migrated over, if the extra mailboxes can be reduced, it will save the Borough money. He mentioned that a representative from AllCovered will be coming to the next meeting to do a presentation to the Council for the emails and the proposal for office 365 emails is currently \$8,530.00. He stated that the backup at the Borough Hall was being done by Dart, but the contract expired and the firewall is not being updated. He mentioned that AllCovered can do the backup for a fee. He suggested

to the Council to compare the price with Dart, since Dart currently does backup for the Police Department.

C/Bauer- asked about the cost of AllCovered for the work.

C/Surak -mentioned that the cost is a one-time fee around \$3,000.00 and a yearly fee of \$1,200.00. Also, he spoke about getting a new server.

Mayor Vaccaro- suggested that the new server should be set up for the new building.

C/Surak -mentioned that he spoke to the Chief about protection for the laptops that are in the police cars to avoid hacking and there are several older computers at the Police Department that need to be updated.

Mayor Vaccaro expressed condolences to Borough Clerk.

Motion by C/Bauer and second by C/Kinsella to adjourn the meeting at 9:14 P.M.
