**BIDS:**

Attorney Migliorino- spoke about previous bids, which the Borough had to dismiss due to some alternation of the project and due to some mistake. He mentioned that he reviewed the bids, and the lowest bidder had to be rejected due to arithmetic errors and unit pricing. He spoke about the second lowest bidder, which was reviewed by him and the architect, and review the work that the company has done before. Spoke about the discussion with the bidder and their attorney. He mentioned that the Borough decided to go with the second lowest bidder and he would like to set up a meeting with the contractor and the contractor's attorney to discuss the project.

Mr. Dressel- asked how the town can be sure of the quality of their work. Mentioned about using another company.

Mayor Vaccaro- spoke about the rolling assessment, the first year, whole town was done, and the remaining years are done 25% each year. Mentioned that he can contact the owner of the company.

Mr. Dressel- spoke about the large home being built in the mobile home park. He mentioned that he spoke to the Building Inspector about building large home at mobile home park.

Mayor Vaccaro- mentioned that there was an issue with the setbacks.

Mr. Dressel -mentioned that he is concerned about the fire load getting bigger. Spoke about the ordinance regarding combustible structures location. He spoke about the situation in Union City with the fire. He mentioned that multiple home were lost in last fire at the mobile home park. He spoke about his concerned about fires that can spread, and the safety of the many people that live there. He suggested to look at the Ordinance for setback for home in the mobile home park.

Mayor Vaccaro- mentioned that he will discuss with the Construction Official.

Lynn Hernandez, 5 Washington Place- mentioned that the sweeper does not go down her street. She asked about the responsibility for cleaning the grass by the railing at the end of the street.

Mayor Vaccaro –mentioned that cars are parked on both side of the street, so the sweeper is not able to get to the street, emergency no parking signs were put up and the cars were still not moved.

Ms. Hernandez -mentioned about problem with cars parking on her street to get to the bus stop and she has problem to get out form her driveway.

Mayor Vaccaro- spoke about the permit parking that was done in the area and parking permit can be added for Washington Place.

Ms. Hernandez- asked about the flooding in her yard, where the land is sinking.

Mayor Vaccaro- mentioned about the ditch being cleaned out and grading the water on the other side.

Sammy Inoue, 37 Edstan Drive -asked about getting help with the work being done on her home.

Mayor Vaccaro- spoke about work that has been done, and asked whether the contractor scheduled inspections.

Ms. Inoue- mentioned that the staircase inside is not installed, the work is on hold and she would like to move back into her home with her family. Also, she mentioned that the contractor said that her husband pushed him and she already paid the contractor.

Attorney Migliorino- mentioned that the DPW Superintendent will send out letters to the owner to notify responsibility for the tree.

Administrator Ciannamea- mentioned that in Moonachie, the property owner is responsible to maintain from the street to the property line.

Ms. Reiner- mentioned that there was a strange car parked in front of her house and she called the Police, she was told that they were from an energy company.

Mayor Vaccaro mentioned that businesses are supposed to apply for a license and notify the Police Department.

Fred Dressel, 1 Sova Pl. -asked why the owner of the mobile home park is not responsible for the work that is done in the parks and whether the owner is aware of work.

Mayor Vaccaro- mentioned that individual owner of the home supposed to notify owner of mobile home park and he will speak to the Building Official.
