The Regular Meeting of the Board of Health of the Borough of Moonachie is called to order by President M. Cinque in the Kathryn E. Flynn Civic Center on September 11, 2017 at 7:41pm.

President called for the Pledge of Allegiance to the Flag.

Secretary stated that notice of the meeting was announced in accordance with the Open Public Meeting Act.

Motion by K. Surak, second by M.Mezzina to waive the Regular Order of Business.

PRESENTATION:

Karen Alelis, Bergen County Department of Health Services- spoke about being here for the Health Officer, and will explain the services that the County Department of Health offers to contracting towns. Spoke about the Health Department passing their recent state audit, and recommendations from the state. County took part in National Public Health week, Secretary attended reception held at the County. It is open for all Board of Health members to attend. Spoke about the hours affecting turnout. M. Cinque asked when the next reception will be.

Ms. Alelis mentioned usually it is during National Public Health Week, in April. Mentioned the County going through process to become an accredited Health Department, which helps with grants and various funding. Spoke about documents that are needed for accreditation.

C/Surak asked if information was on the County website to link to the Borough website.

Ms. Alelis spoke about Local Board of Health Registry, and will request information for February.

M. Cinque asked about the questions for the audit.

Board reviewed questionnaire matrix.

M. Cinque asked about Board of Health training.

Ms. Alelis mentioned trainings are not required, but are recommended. Mentioned other opportunities.

M. Cinque asked if there was a cost if they wanted to take the Food Handler's class.

Ms. Alelis she would have to look into it at the County. Mentioned online website for trainings. Spoke about Medical Reserve Corps and CERT team.

M. Cinque asked about qualifications.

Ms. Alelis spoke about the training for the Medical Reserve Corps. Mentioned about communicable disease reporting is done electronically, and process of notifying the patient and going to Health Consultations. The date of the Flu Clinic is October 18th 11-12pm. Health Promotions offers various programs to help the community. Need to find the needs of the residents and the Board of Health. Spoke about the free programs that are offered through the County.

M. Cinque asked how long the programs are.

Ms. Alelis mentioned that the times can vary depending on the audience, children or adults. Spoke about the County offering tables for Town Days and fairs. Mentioned longer courses that are for 6 weeks, Chronic Disease Self-Management. Spoke about Stigma Free initiative for mental illness and mental health first aid course. She can have someone from the County come to an upcoming Board of Health meeting to speak about joining. Spoke about 8-hour course for mental health first aid. Mentioned school data, amount of homelessness in Moonachie. Spoke about events coming up in

Ms. Alelis mentioned that the Rutgers Extension is in the County building. They may have a program regarding planting in the ground.
